#### **Agenda no. 1**

Regarding confirmation of the minutes of the meeting dated 01.8.201 of the Academic Council.

#### **Agenda no. 2.**

Regarding organizing university examination of BLIS course of the session 2016-2017 in annual system as per proposal of the Director, DDE, P.U. received his letter no.DDE/AC/39 dated 21.4.2017.

**It was resolved to send a letter to the Governor's Secretariat, Bihar with a request to permit the Directorate of Distance Education to continue the B.Lib Sc. Course as per the provisions of the old Regulations approved vide the letter memo no.PUI/81-1507/GS(I) dated 27.5.1981 of the Governor's Secretariat, Bihar for the sessions 2015-2016 and 2016-2017. In the letter to be sent to the Governor's secretariat, Bihar, it be mentioned that the result of the BLIS course students of DDE, P.U. for the session 2015-2016 had been declared**

according to the old Regulations of BLIS approved vide the letter no memo no. PUI/81-1507/GS(I) dated 27.5.1981 of the Governor's Secretariat, Bihar by the order of the then Vice-Chancellor. Meanwhile, the necessary amendments will be made in the existing Ordinance and Regulations approved vide letter no. PU(Regulations)07/2015-359/GS(I) dated 24.03.2015 for the candidates opting Distance mode.

**Agenda no. 3.**

**Additional Agenda no. 07**

Regarding approval of the proposed amendments in the existing examination regulations para. 7.5 of M.S.W. received vide letter no. 332 dated 29.05.2017.

It was also resolved that for other Post Graduate Courses under semester system, amendment in the relevant clause of the examination regulations of the courses be made that the students shall continue to get promotions in the next semester as per the provisions of the relevant clause of the Regulations concerned. In the final semester he/she will be allowed to appear in the examinations if other conditions are fulfilled. However, the result of the final semester will be kept pending till the candidate passes the examinations of all the previous semesters.



**Additional Agenda no. 08**

There is provision for Re-Appearance in Examination to Improve Class as per Regulation Relating to Re-appearance in Examination to Improve Class (No.BSU-43/86-3928/GS(I) dated 15.12.86). The examination section has rejected the examination forms of the candidates who has passed out M.A. / M.Sc. /M.Com examinations last year.

**It was resolved to seek a direction from the Governor's Secretariat whether the above provisions of the Improvement will continue under the semester system.**
