In the beginning of the meeting, the Vice Chancellor welcome all the members, especially the new members and then, the business of the meeting started.


Agenda1:-Regarding confirmation of the minutes of the meeting dated 04.7.2019 of the Academic Council.







Resolution: - It was resolved to approve the names of experts for the above-noted 16 subjects for the selection committee in reference.


