Subject: - Guidelines regarding admission in Ph.D. Programme


Sir/Madam

In pursuance of the decision taken at the meeting of the Deans of the Faculties and the Heads of the Departments held on April 4, 2019 in the light of the Hon'ble High Court Judgement passed in CWJC No. 13693 of 2018 Rakesh Kumar & Ors. Vs The State of Bihar & Ors. and in continuation of this office letter no. Acad./- 7509 dated 30.03.2019, I am directed to request you to follow the following Guidelines for admission in Ph.D. programme:

- a. The admission in Ph.D. programme will be against the seats declared vacant on the date of admission notice issued in April 2018.
- b. The marks of the NET which is of 300 will be converted in 200 i.e. the marks of PRT/PAT of Patna University for preparation of merit list.
- c. The candidates who have not submitted the marks of NET will have to submit it latest by April 10, 2019 failing which their candidature will not be considered.
- d. The merit list should be prepared on the basis of 220 marks i.e. 200 marks of PRT/PAT/NET and 20 marks of Interview / Viva voce.
- e. The final merit list will be approved by the Department Council on the basis of availability of seats and reservation policy of the State Government.

- f. At least two to three candidates of each category will be kept in waiting list for admission in case the selected candidates do not turn up for admission within due date.
- g. The Department will publish the final selection list on its notice board and same should be forwarded to the Incharge, Patna University Computer Centre for uploading on the Patna University website as per clause 6.2 of the Uniform Ordinance & Regulations. A copy of the merit list will be sent to the Registrar, Patna University latest by April 11, 2019.
- h. A letter will be issued by the University on the basis of the recommendation of the Department for Provisional Admission in the Ph.D. programme and the finally selected candidate will have to deposit online Course Work fee of Rs. 2000/- (two thousand) only latest by April 21, 2019 as per the provision contained in clause 7.1 of the Uniform Ordinance & Regulations.
- i. The Course work for the provisionally admitted students will begin from April 22, 2019 at the faculty level.
- j. As per the provision contained in clause 7.2. & 7.3 of the Uniform Ordinance and Regulations, the Course Work of one semester would include two papers. Paper I will be conducted by Faculty concerned and Paper II will be conducted by the Department concerned.




