- Eligibility criteria of the contractor participating in the tender:
 - Registered contractor of Govt. of Bihar/C.P.W.D./ M.E.S. for appropriate category for civil & Electrical work. Working contractor of Patna University is only applicable for small work (up to ₹1, 00,000) one lakh only.
 - For new construction work, the agency should have past experience for same nature of work at list 50% of tender amount.
 - As per amendment by resolution of Rule no. 159 (a) & 159 (b) of Public Works Code vide memo no. प्र0 7/नियम-01/2015/5931(5), Patna, dated 01/07/2015, 50% work will be reserved for SC, ST, EBC, BC and BC(Ladies) upto ₹ 15 Lacks of work value.**
 - The Name of work and its serial No. as per NIT should be mentioned in the front of Envelop, otherwise tender will not opened.**
- As per amendment by resolution of Rule no. 159 (a) & 159 (b) of Public Works Code vide memo no. प्र0 06/1/बी0/12/2003-5676(5), Patna, dated 24/06/2015, the tender of ₹ 15 Lacks or less will not be required to publish in daily newspaper.
- Any other information may be obtained from the office of the University Engineer, Patna University, Patna during working hours in any working day.
- The estimated cost may increase or decrease but the earnest money will remain the same.
- The work order will issued subject to the availability of fund.

B.O.Q. submitted without cost of B.O.Q. in the form of demand draft will be summarily rejected and the last date for downloading the tender document from the website is one day prior to the last day of receipt of tender. Accordingly the draft towards the tender fee shall be dated one day prior to the last date of receipt of tender.**
12. The sealed tender(s) should also be sent through Courier/Registered/Speed Post. Conditional tender or tenders received after the due time and date shall not be entertained in any circumstances. Patna University would not be responsible for any delay or loss of the tender document, The tender(s) will be opened in the office of the undersigned by the duly constituted committee as per the above mentioned schedule in presence of any intending supplier or his/her authorized representative who may wish to be present at the designated time and place. If the fixed date turns out to be the holiday, the date of opening will be the next day.
